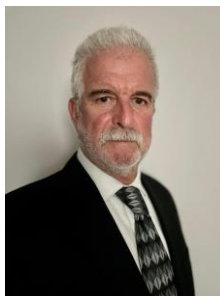

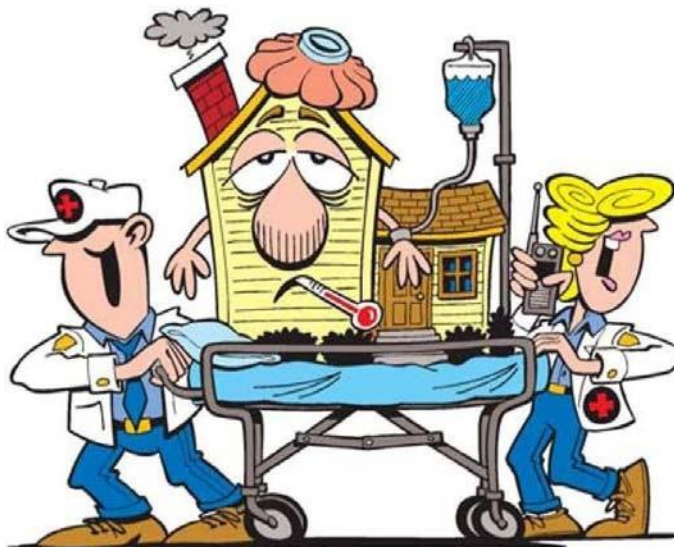
“Events” can be a flood or a contamination from adjacent properties, chemical spills, defective materials and industrial pollution releases.

- Asthma

- Chronic fatigue
- Skin irritation
- Central nervous problems, constant headaches, memory problems, and mood changes
